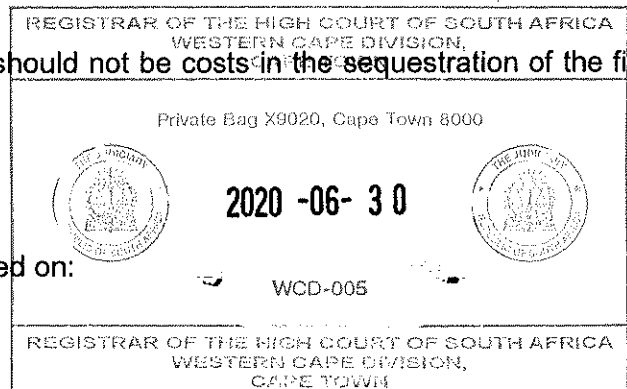
**DRAFT ORDER**

Having heard counsel for the applicant and read the papers filed of record, **it is ordered that:**

1. The estate of the first respondent is placed under provisional sequestration;
2. A rule *nisi* is issued calling upon the first respondent and all interested parties to show cause, if any, to this Honourable Court on **Wednesday, 29 July 2020 at 10h00** or so soon thereafter as counsel may be heard, why:

2.1. The first respondent's estate should not be placed under final sequestration; and

2.2. The cost of this application should not be costs in the sequestration of the first respondent's estate.



3. Service of this order is to be effected on:



3.1. The first respondent at 1 Darter Close, Bluewater Estate, Kommetjie, Western Cape;

3.2. The second respondent at 1 Darter Close, Bluewater Estate, Kommetjie, Western Cape;

3.3. The South African Revenue Service at 22 Hans Strijdom Avenue, Cape Town, Western Cape; and

3.4. the employees (if any) (and any registered trade union representing the employees) of the first respondent at 1 Darter Close, Bluewater Estate, Kommetjie, Western Cape.
